THE RUST FOUNDATION EXISTS TO SUPPORT THE RUST PROJECT AND ECOSYSTEM, TO ENSURE THAT THE RUST PROGRAMMING LANGUAGE IS ROBUST AND FIT FOR PURPOSE. DURING 2024 THE FOUNDATION CONTINUED TO SUPPORT THE MAINTENANCE OF THE RUST LANGUAGE INFRASTRUCTURE THROUGH ITS CURRENT INFRASTRUCTURE ENGINEERING ROLE, HIRED A FURTHER EMPLOYEE TO WORK ON THE EFFICIENCY, SUSTAINABILITY AND SECURITY OF THIS CRITICAL INFRASTRUCTURE, AND SECURED OVER \$2 MILLION OF DONATED CLOUD COMPUTING SERVICES. THE FOUNDATION ALSO ENSURED THAT THE PACKAGE REPOSITORY UNDERPINNING THE RUST LANGUAGE WAS STABLE AND SECURE, THROUGH FUNDING 24HR ON-CALL SERVICES TO ENSURE ITS CONTINUITY OF SERVICE. \$413,000 WAS AWARDED IN GRANT FUNDING TO VOLUNTEER MAINTAINERS. THE INITIATIVE IS A GLOBAL EFFORT AND HAS ENGAGED STAKEHOLDERS FROM ACROSS INDUSTRY AND FROM AROUND THE WORLD. ACTIVITIES UNDERTAKEN INCLUDED INVESTING IN THREAT MODELING, DEVELOPING RISK ASSESSMENTS AND THE DEVELOPMENT OF TOOLING, FEATURES AND PROCESSES TO MITIGATE OR ELIMINATE SECURITY THREATS.
